AN ORDINANCE TO AMEND
CHAPTER 25 OF THE REVISED CODE OF ORDINANCES

WHEREAS, the Board of Trustees ("Board") of the Village of Mulberry Grove, Illinois ("Village"), previously adopted certain ordinances to establish, regulate, and abate nuisances within the Village, with such provisions begin generally found in Chapter 25 of the Revised Code of Ordinances of the Village of Mulberry Grove ("Code"); and

WHEREAS, Chapter 25 of Code addresses regulates, *inter alia*, Inoperable Motor Vehicles and declares such vehicles to be a nuisance; and

WHEREAS, the Board has determined that it is necessary to adopt and amend Chapter 25 of the Revised Code of Ordinances of the Village of Mulberry Grove to more appropriately regulate Inoperable Motor Vehicles for the health, safety, and benefit of the residents of the Village and the general public.

NOW THEREFORE, BE IT ORDAINED BY PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MULBERRY GROVE:

SECTION 1: Chapter 25-4-4 of the Revised Code of Ordinances of the Village is hereby deleted in it's entirety and amended to hereafter read as follows:

25-4-4 MOTOR VEHICLES. Nothing in this Article IV shall apply to any motor vehicle that is kept within an enclosed building when not in use, to any operable historic vehicle over twenty-five (25) years of age when stored within an enclosed building, or to a motor vehicle on the premises of a licensed business engaged in the wrecking or junking of motor vehicles.

SECTION 2: This Ordinance shall be effective upon its due publication in pamphlet form as by ordinance and statute otherwise provided.
