ORDINANCE NO. 703

AN ORDINANCE AMENDING CHAPTER 38 OF THE REVISED CODE
OF ORDINANCES FOR THE VILLAGE OF MULBERRY GROVE,
ILLINOIS AS TO TAP-ON AND DISCONNECTION FEES

WHEREAS, the Board of Trustees of the Village of Mulberry Grove, Illinois, have determined that it is necessary to adopt and amend Chapter 38 of the Revised Code of Ordinances of the Village of Mulberry Grove to change the water rates for Village residents because of the increase in the cost of providing water and related services to the Village's water customers.

NOW THEREFORE, BE IT ORDAINED BY PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF MULBERRY GROVE:

SECTION 1: Chapter 38-4-10 of the Revised Code of Ordinances of the Village is hereby amended to hereafter read as follows:

38-4-10 WATER TAP-ON FEES.

(A) **Inside Village.** Applicants for water service inside the Village shall pay a charge of **Two Thousand Dollars (\$2,000.00)**. All labor and materials such as connecting pipes, meter vaults and covers, valves, connections and **thirty (30) feet** of line are included in the fee. For meters larger than **three-fourths (3/4) inch**, the tap-on fee will be the actual cost of installing, labor and materials plus **ten percent (10%)** for overhead.

(B) **Outside Village.** Applicants for water service outside the Village limits shall pay **Two Thousand Five Hundred Dollars (\$2,500.00)**. All labor and materials such as connecting pipes, meter vaults and covers, valves, connections and **thirty (30) feet** of line are included in the fee.

SECTION 2: Chapter 38-2-1(H) of the Revised Code of Ordinances of the Village is hereby amended to hereafter read as follows:

38-2-1 CONTRACT FOR UTILITY SERVICES.

* * *

(H) Billing; Utility Shut-Off/Temporary Disconnection.

(1) Bills for water and sewer service shall be sent out by the Village no later than the **twenty-fifth (25th)** of the month preceding the period

for which the service is billed. All bills are due and payable on the **tenth (10th) day** of the following month. A service charge of **ten percent (10%)** shall be added to all bills not paid by the **tenth (10th) day** after they are rendered and paid before the **thirtieth (30th) day** after they are rendered.


- (2) Any customer who fails to pay the utility bills in full within **sixty (60) days** of mailing shall have the utility services disconnected not less than three (3) days after a written notice by the Clerk has been mailed by first-class mail to the customer.
- (3) Once utility services have been disconnected, the same shall not be again connected or used until all delinquent accounts and bills of service for such customer, irrespective of service address, are paid in full, including a fee of **One Hundred Dollars (\$100.00)** for each re-connection of such utility services thereafter, plus any reasonable expenses incurred in the reconnecting of the utility services, including, but not limited to, reasonable attorneys' fees, any fees or expenses of an necessary licensed professional.

SECTION 3: This Ordinance shall be effective upon its due publication in pamphlet form as by ordinance and statute otherwise provided.
