ORDINANCE NO. 676

**AN ORDINANCE TO AMEND THE FENCE CODE FOR THE
VILLAGE OF MULBERRY GROVE, ILLINOIS, AMENDING
CHAPTER 20 OF THE REVISED CODE OF ORDINANCES**

WHEREAS, the Board of Trustees of the Village of Mulberry Grove, Illinois, have determined that it is necessary to adopt and amend Chapter 20 of the Revised Code of Ordinances of the Village of Mulberry Grove to change the Fence Code for Village residents.

NOW THEREFORE, BE IT ORDAINED BY PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MULBERRY GROVE:

SECTION 1: Section 20-1-9 (G)(1) of the Revised Code of Ordinances of the Village is hereby amended to hereafter read as follows:

(G) Enclosures for swimming pools and athletic facilities:

(1) *Swimming pools.* RESERVED.

SECTION 2: Section 20-1-6 of the Revised Code of Ordinances of the Village is hereby amended to hereafter read as follows:

20-1-6 PERMIT FEES.

The fee for permits issued for the erection or alteration of fences shall be \$50.00.

SECTION 3: This Ordinance shall be effective upon its due publication in pamphlet form as by ordinance and statute otherwise provided.
