ORDINANCE NO. 680

**AN ORDINANCE TO AMEND THE ZONING CODE FOR THE
VILLAGE OF MULBERRY GROVE, ILLINOIS, AMENDING
CHAPTER 40 OF THE REVISED CODE OF ORDINANCES**

WHEREAS, the Board of Trustees of the Village of Mulberry Grove, Illinois, have determined that it is necessary to adopt and amend Chapter 40 of the Revised Code of Ordinances of the Village of Mulberry Grove to change the zoning code for Village residents for the purpose of making adequate provision for the enforcement of the comprehensive Village plan for the guidance, direction and control of the growth and development of the Village.

NOW THEREFORE, BE IT ORDAINED BY PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MULBERRY GROVE:

SECTION 1: Chapter 40-5-6 of the Revised Code of Ordinances of the Village is hereby amended to hereafter read as follows:

40-5-6 BUILDINGS UNDER CONSTRUCTION. Nothing in this Code shall be deemed to require any change in the plans, construction or designated use of any building upon which actual construction was lawfully begun prior to the adoption of this Code, and upon which building, actual construction has been diligently carried on, and provided, further, that such building shall be completed within **one (1) year** from the date of passage and publication of this Code.

Unless construction is started within four (4) months after the date of issuance of a building permit, the building permit shall automatically become void and fees forfeited. The Zoning Administrator may reinstate a building permit that has become void for failure to commence construction with payment of a \$50.00 re-instatement fee and applicant's proof of continued compliance with all applicable statutes, laws, regulations, and ordinances. Re-instatement fee may be waived at the discretion of the Zoning Administrator upon good cause shown.

SECTION 2: Except as otherwise provided herein, the remaining terms and provisions of Chapter 40 of the Revised Code of Ordinances of the Village, except as may be required to give fair interpretation of the amendment hereby provided, is ratified and reaffirmed without change or amendment.

SECTION 3: This Ordinance shall be effective upon its due publication in pamphlet form as by ordinance and statute otherwise provided.




