ORDINANCE NO. 689

AN ORDINANCE ESTABLISHING AND PROVIDING
FOR THE ESTABLISHMENT OF NO PARKING ZONES
IN THE VILLAGE OF MULBERRY GROVE, ILLINOIS

WHEREAS, the Board of Trustees ("Board of Trustees") of the Village of Mulberry Grove Village, Illinois ("Village") has determined that the traffic, parking, and general use of certain streets within the Village limits are or may be a threat to the health, safety and welfare of people and property in the municipality; and

WHEREAS, the Board of Trustees has determined that the current regulations governing parking along certain streets are inadequate; and

WHEREAS, the Board of Trustees has determined that the public safety will be promoted by establishing certain No Parking Zones throughout the Village; and

WHEREAS, all affected streets are located within the corporate limits and/or jurisdiction of the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF VILLAGE OF MULBERRY GROVE, BOND COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: No Parking Zones are hereby established at the following locations:

- a. Both sides of Pierce Avenue from Oak Street to Mulberry Grove Road.
- b. Both sides of Old Park Road North of East Main Street.
- c. The Eastern side of the entirety of Oak Street.
- d. Both sides of the entirety of North Street.
- e. Both sides of North Wood Street from East Tower Street to School Street.
- f. The Western side of North Wood Street from School Street to King Street.
- g. Both sides of the entirety of Carman Drive.

- h. Both sides of 2nd Street from Market Street to West Wall Street.
- i. The Eastern side of 3rd Street from Tower Street to West Wall Street.
- j. Both sides Tower Street from 7th Street to Maple Street.
- k. Both sides of Market Street from 7th Street to Maple Street.
- l. Both sides of 7th Street from West Wall Street to Highway 40 West.
- m. Both sides of West Taylor Street from 7th Street to Maple Street.
- n. Both sides of the entirety of South Street.
- o. The Western side of the entirety of Orchard Street.

Section 2: No Parking signs conforming to the Illinois Department of Transportation Sign Manual and Specifications shall be installed adjacent to the streets in Section 1, such streets being within the corporate limits or jurisdiction of the Village. The location of these signs shall conform to the requirements of the Illinois Department of Transportation Sign Manual and Specifications.

Section 3: Any person who disobeys the No Parking signs to be placed pursuant to this ordinance shall be guilty of the offense of failing to obey a No Parking Zone and shall be fined in accordance with the Village Ordinances for each such offense.

Section 4: The Revised Code of Ordinances of the Village is hereby amended to reflect the above-described No Parking sign placement, and all provisions thereof and any prior ordinances of the Village to the contrary are hereby repealed and replaced.

Section 5: If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and, to this end, the sections and provisions of this Ordinance are declared to be severable.

Section 6: The high volume of traffic and concerns for safety make it urgent that this Ordinance be effective immediately upon adoption, pursuant to Section 1-2-4 of the Illinois Municipal Code.

Section 7: This Ordinance has been approved by two-thirds (2/3) of the Trustees now holding office. It shall be published in pamphlet form.


