SECTION III. That the salaries of the various employees of the Village of Mulberry Grove for the fiscal year beginning May 1, 2025, and ending April 30, 2026, and expenses and mileage limitations therefore, are hereby fixed, determined as herein provided.

SECTION IV. That in lieu of a Village Attorney as an officer of the Village, there shall be retained an attorney for the fiscal year concerned, as attorney for the Village, to handle the routine legal and administrative matters of the Village. Said attorney shall be compensated for such routine legal and administrative matters at the rate not to exceed \$375.00 per hour plus the attorney's out-of-pocket expenses. Such attorney shall be so retained and engaged to provide legal assistance to the Board of Trustees and President, including the drafting of various ordinances and resolutions to be considered by the Village Board and President, to attend Village Board and other meetings as requested to provide legal advice concerning the matters considered therein, to research and tender legal and opinions upon such legal or administrative matters as may, from time to time, be requested. The retention and charges hereinabove set forth relate only to such routine matters specified, and shall not be deemed to relate to legal proceedings before any court, tribunal or administrative agency or in regard to any bond issue, which such proceedings or matters shall be handled, as from time to time required, upon the basis of the attorney's usual and customary retainers, charges for service and out-of-pocket expenses relative to such matters or proceedings.

SECTION V. That unless otherwise indicated, the unexpected or unexpended balances, if any, of fiscal years prior to the one concerned herein are hereby specifically re-appropriated for the same general purposes for which they were originally made.

SECTION VI. That all unexpected or unexpended balances in any item or items of general appropriation made in this Ordinance may be expended for the purpose of defraying any deficiency in any other item or items in the same general appropriation for the same general purpose.

SECTION VII. That in the event any general or specific item, or portion thereof, of this Appropriation Ordinance is, for any reason, held invalid, such invalidity shall not affect the validity of the remaining portion or portions of this Ordinance.

SECTION VII: That this Ordinance shall be effective upon its due publication in pamphlet form as by ordinance and statute otherwise provided.

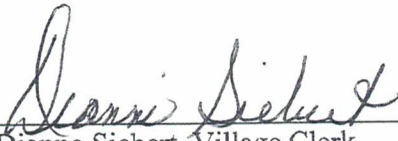
