ORDINANCE NO. 2025- 702

AN ORDINANCE FOR LEVY AND ASSESSMENT OF TAXES FOR
THE VILLAGE OF MULBERRY GROVE, ILLINOIS FOR THE FISCAL
YEAR BEGINNING MAY 1, 2025 AND ENDING APRIL 30, 2026

WHEREAS, the President and Board of Trustees of the Village of Mulberry Grove, Bond County, Illinois, duly passed on the 8th day of December, 2025, Ordinance Number 2025-702, being titled:

AN ORDINANCE ADOPTING APPROPRIATIONS
AND CERTIFYING ANTICIPATED REVENUES
FOR THE VILLAGE OF MULBERRY GROVE
FOR THE FISCAL YEAR BEGINNING
MAY 1, 2025 AND ENDING APRIL 30, 2026

(the "Appropriation Ordinance") which was duly published in pamphlet form in the Village of Mulberry Grove, Illinois; and

WHEREAS, said Appropriation Ordinance is now in full force and effect and on file with the Clerk of the Village of Mulberry Grove, Illinois; and

WHEREAS, the President and the Board of Trustees of the Village of Mulberry Grove, Illinois, have ascertained the total amount of such appropriations, legally made for all corporate purposes, to be provided for by means of a tax levy for said current fiscal year; and

WHEREAS, the President and Board of Trustees duly passed on the 1st day of December, 2025, Resolution Number 2025- 702 whereby it was determined pursuant to the Truth in Taxation Act of the State of Illinois, that no Truth in Taxation Notice or hearing is required prior to adoption of this Ordinance for Levy and Assessment of Taxes for the Village of Mulberry Grove, Illinois for the Fiscal Year Beginning May 1, 2025 and Ending April 30, 2026 ("Levy Ordinance");

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MULBERRY GROVE, BOND COUNTY, ILLINOIS, AS FOLLOWS:

SECTION I: That the total amount of appropriations for all corporate purposes legally made and to be collected from the tax levy for the fiscal year beginning May 1, 2025 and ending April 30, 2026, is hereby ascertained to be Sixty Eight Thousand Four Hundred and 00/100 Dollars (\$68,400.00).

SECTION II: Sixty Eight Thousand Four Hundred and 00/100 Dollars (\$68,400.00), being the total of all leviabale appropriations heretofore legally determined by said Appropriation Ordinance, is hereby levied upon all of the taxable property within the Village of Mulberry Grove, Illinois subject to taxation for the current fiscal year, for the following specific purposes:

SECTION III: Sixty Eight Thousand Four Hundred and 00/100 Dollars (\$68,400.00) ascertained as set forth above, is hereby levied and assessed upon all property subject to taxation within the Village of Mulberry Grove, Bond County, Illinois, according to the value of said property as assessed and equalized for State and County purposes within the fiscal year here concerned.

SECTION IV: That there is hereby certified to the County Clerk of Bond County, Illinois, the several sums above set forth, which are required to be raised by levy and taxation.


SECTION V: That the Village Clerk be authorized and directed to duly certify a copy of this Levy Ordinance and file such certified copy of this Levy Ordinance with the County Clerk of Bond County, Illinois, on or before the time required by law.

SECTION VI: That this Levy Ordinance shall take effect and be in full force and effect ten days after its passage, approval, and publication in pamphlet form as provided by law.







TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of the Village of Mulberry Grove, Illinois, and as such presiding officer I certify that the levy ordinance, a copy which is filed with the County Clerk, was adopted pursuant to, and in all respects in compliance with the provisions of Section 215/4 through Section 215/7 of the "Truth in Taxation Act." The Village of Mulberry Grove, Illinois levied an amount of ad valorem tax that is less than or equal to 105% (.05%) of the final aggregate/total levy extension of the preceding tax year based upon information currently available. The notice and hearing requirements of Section 18-70 of the Act are inapplicable, and the notice requirements of Sections 18-75 through 18-85 are inapplicable.

This Certificate of Compliance for the "Truth in Taxation Act" applies to the Village of Mulberry Grove, Illinois Levy for the Tax Year 2025.



TAX LEVY COLLECTIBLE IN 2026**



WHEREAS, The Trustees have duly deliberated on the estimate of the annual aggregate levy.


